Amendments to the Management Plan for the Ngari Capes Marine Park Management Plan 74 2013-2023

These amendments to the *Ngari Capes Marine Park management plan 74 2013-2023* were approved by the Minister for Environment on 15 February 2018. The amendments to the management plan came into operation on 2 March 2018, following publication in the *Government Gazette*.

a) The following paragraph replaces all text under the heading of 'Special purpose zones (surfing)' on page 17 of the *Ngari Capes Marine Park management plan 74 2013-2023.*

Special purpose zones (surfing)

The purpose of these zones is to recognise and provide for surfing as a priority use. This zoning recognises the high social value of surfing, including body surfing, board riding, body boarding, surf skiing, wave skiing, kitesurfing and windsurfing. The conservation purpose of these zones is to provide protection of nearshore and offshore habitats. Commercial fishing activities that are considered to be incompatible with the conservation purpose of these zones are: rock lobster fishing, trawl fishing, commercial coral, live rock and live sand collecting, commercial octopus fishing and aquaculture. Recreational fishing activities that are specimen shell collecting (alive), coral and live rock collecting and octopus or rock lobster fishing with pots. Recreational rock lobster fishing with pots is permitted in the Margaret River Special Purpose Zone (Surfing).

b) The following paragraph replaces all text under the headings 'Special purpose zones (shore-based activities)' and 'Recreation zones 'on page 18 of the *Ngari Capes Marine Park management plan 74 2013-2023.*

Special purpose zones (shore-based activities)

Special purpose zones (shore-based activities) recognise and specially provide for existing nodes of high coastal use. The conservation purpose of these zones is to provide protection to nearshore habitats and communities. Commercial fishing activities other than shore-based abalone, aquarium, and specimen shell collecting are considered incompatible with the conservation purpose of these zones. The following recreational fishing activities are considered incompatible with the conservation purpose of these zones: fishing using a boat, specimen shell collecting (alive), coral and live rock collecting, octopus fishing using pots or traps, spearfishing and fishing from a charter vessel. Activities permitted in this zone include nature appreciation and some shore-based commercial and recreational fishing activities where fishers must be on the shore while fishing.

Recreation zones

Recreation zones provide for the protection of ecological values while permitting compatible recreational activities including fishing. Hamelin Bay and Cowaramup Bay are areas of high recreational value and use for visitors. The recreational purpose of the Hamelin Bay Recreation Zone is to provide for an ongoing high quality recreation experience at a known tourism node. Recreational fishing activities that are considered to be incompatible with the recreational purpose of this zone are: specimen shell collecting (alive), coral and live rock collecting and fishing from a charter vessel. The recreational purpose of the Cowaramup Bay Recreation Zone is to provide a family oriented recreation beach. Recreational fishing activities that are considered to be incompatible with the recreational purpose of the cowaramup Bay Recreation Zone is to provide a family oriented recreation beach. are: crabbing for species other than blue swimmer crabs, specimen shell collecting, coral and live rock collecting, octopus fishing and fishing from a charter vessel.
