Credit facilities will only be granted to commercial operations licence holders who can demonstrate:

- 1. The account will be active to the extent of at least \$1000 per month (allowing for seasonality) as determined by the Tourism Partnerships Manager.** Please provide proof that should you be granted a credit account, that it will be held active to at least \$1000 per month. This may include a description of your credit history with DBCA or with another agency as well as supporting documentation.

- 2. A good credit record (DBCA history or other referees).** Please provide proof of your good credit rating with DBCA or other creditors. This may include a description of your payment history as well as supporting documentation. Otherwise, please provide the contact details of trade referees who can support your claim.

DBCA reserves the right to request a bank guarantee from a licence holder that would be equal to the amount of credit required. Licence holders would still be required to comply with DBCA's payment requirements.

All licence holders requesting credit facilities that are a company or incorporated body will be required to provide a personal [Director's Guarantee](#) (located in Downloads section). **For further information please contact the Licensing Officer.**

- Non payment of accounts in accordance with DBCA's requirements (see licence conditions);

- The Director's Guarantee or Bank Guarantee becomes null and void, expires, is cancelled or ceases to be valid by any other means; or
- For any other reason at the discretion of the Tourism Partnerships Manager.

I agree that in the event I do not pay to the Director General all monies owing to the Director General within 60 days of the date of the invoice the Director General may charge interest on those monies at a rate of 15% per annum until the actual payment is made in full. I agree to pay the Director General all interest charged by the Director General, and to pay all the Director General's costs (including legal and debt recovery cost and fees) incurred in recovering monies which I may owe to the Director General.

I, the licensee, by signing below specifically agree and acknowledge with the Department of Biodiversity, Conservation and Attractions as follows:

That the Department of Biodiversity, Conservation and Attractions hereby inform me that it may disclose to a credit reporting agency certain personal information about me including; information included in this application; my identification; the amount of credit applied for; payments which may become more that 60 days overdue; advice that payments are no longer overdue; a serious infringement which the Department of Biodiversity, Conservation and Attractions believes I have committed. That the Department of Biodiversity, Conservation and Attractions in assessing this application and any later requests, may obtain from a credit reporting agency a credit report containing information about my commercial activities or commercial credit worthiness. The Department of Biodiversity, Conservation and Attractions may give to and obtain from, any third party, information about my personal or commercial credit arrangements including information about my credit worthiness, credit standing, credit history or credit capacity for the particular purpose for which the information is required.
