## Are you interested in cultural tourism?

The Department of Biodiversity, Conservation and Attractions (DBCA) *Culture in the Parks* program encourages Aboriginal people and/or Aboriginal organisations wishing to conduct Aboriginal cultural tours or events in WA's national parks and reserves.

#### Background

Aboriginal people are the custodians of the land and waters managed by the department. The department respects the important roles and knowledge Aboriginal people have as Traditional Custodians and is committed to building strong relationships with Aboriginal people to care for country.

DBCA is seeking interest from Traditional Custodians wishing to conduct cultural tours or events on national parks, marine parks, nature reserves and regional parks.

DBCA works to conserve WA's biodiversity, cultural and natural values. We also provide outstanding nature-based tourism and recreation experiences for the community. We:

- manage WA's parks, forests and reserves for conservation

Aboriginal businesses that operate on country can offer unique tourism opportunities such as:

- boat tours
- walking on country
- bush tucker tasting
- sharing language and stories
- providing transport.



#### What can Aboriginal operators offer?

Aboriginal operators can hold a commercial event or develop a tourism business that celebrates Aboriginal culture. These help to increase the level of public knowledge and respect for Aboriginal heritage and culture. The opportunities are endless, including partnerships with non-Aboriginal commercial operators.
